maximum two lines, in CAPITAL LETTERS,
size 14 Times New Roman (bold).

Paper body: Word for Windows, Times
New Roman, size 14, single space. Page mar-
gins: 2 cm top, bottom, left, right.

Subtitles – centered, bold (first letter capital),
size 14, Times New Roman.

Please do not number pages!

Literal and grammar mistakes have to be
checked.

Authors' data: names of the authors below
paper title, 2 lines space, size 14, Times New
Roman. Please specify author's full name and
surname, title, position, name and address of the
institution, telephone number and e-mail (in the
footnotes)

References: have to be placed at the end of
the paper. Bibliographic unit should contain:
surname and name of the author (co-author),
year of edition, paper title, editor, publishing
place and quoted pages from-to. Bibliographic
units should match to alphabet queue of authors'
surname or title of the journal and publications.
